COMMITTEE/WORKING GROUP/TASK FORCE DEFINITIONS

Bylaw Committee: makes necessary changes to the Association bylaws when needed.

Membership/Education Committee: will plan the membership forums quarterly for the Association. Researching locations and speakers in DeKalb County & Ogle County. Plans yearly continuing education for the members of the Association.

Finance Committee: meets as needed for Association finances and approves the annual budget of the Association.

Legislative Committee: attends local legislative events, council meetings and keeps up to date on legislation that affects homeowners of real estate and real estate. Committee members are also encouraged to attend Capital Conference.

M.O.W. Meals-On-Wheels Committee: plans the yearly schedules for delivering Meals-On-Wheels in the DeKalb/Sycamore area for the month of December.

Professional Standards Committee: meets as needed by the Illinois Association of REALTORS® for hearings on complaints filed and forwarded by the Grievance Committee. Committee members will be required to attend yearly training in Rockford once a year to keep updated.

Nominating Committee: 5 REALTOR® Members of the Association including the immediate Past President and 1 other Past President of the Association will meet to review possible candidates for director/Officer positions for the Association and will recommend a yearly slate for the members to vote on.

Social Committee: Plans the Golf Outing, Spring Event, Education Fundraiser and any fun events planned for the membership throughout the year.

GEN X & Y Task Force: will meet and discuss ideas and services that GEN X & Y members are seeking from the Association.
